### **Mission**

The Alliance to Protect Nantucket Sound is a 501 (c)(3) non-profit environmental organization dedicated to the permanent preservation of Nantucket Sound, the historic body of water that lies between Cape Cod and the Islands of Martha's Vineyard and Nantucket. The Alliance was formed in 2002 in response to Cape Wind's proposal to build a 25-square-mile wind energy project in the Sound. The goal of the Alliance is to establish the Sound as a protected area to preserve its rich ecology and safeguard the Sound against future inappropriate development.





### **Alliance opposition to Cape Wind**

While the Alliance supports sensible renewable energy projects, it opposed Cape Wind based on significant adverse economic, environmental, and public safety impacts, including:

- Substantial visual, noise, and light pollution
- Increased electric costs for ratepayers across Massachusetts
- Danger to air and sea travel due to location and radar interference
- Destruction of a national treasure and tribal lands
- Violation of the public trust through use of public land for private gain
- Decline in tourism, jobs, and property values
- Harm to birds, fish, and marine mammals including endangered species
- Disruption of commercial fishing
- Threat of an oil spill





# **Cape Wind Surrenders**

NOTICE TO THE BOEM OF PROJECT ABANDONMENT AND SURRENDER

AND APPLICATION FOR RELINQUISHMENT OF COMMERCIAL LEASE FOR

RENEWABLE ENERGY DEVELOPMENT ON THE OUTER CONTINENTAL SHELF

Please be advised that Cape Wind Associates, LLC has abandoned development of the proposed Cape Wind offshore wind project in Nantucket Sound and ceased all operation and accordingly hereby surrenders the associated Commercial Lease for Renewable Energy Development on the Outer Continental Shelf No. OCS-A-0478 and applies to relinquish said Lease pursuant to Section 285.435 of the BOEM's regulations.

# Massachusetts/Rhode Island Offshore Wind Energy Areas

Based on a public process with stakeholder input, the federal government identified offshore Wind Energy Areas (WEAs) along the east coast that aim to minimize conflicts and be suitable for development. Five developers now hold leases offshore of Massachusetts and Rhode Island: Deepwater Wind (acquired by Orsted), Vineyard Wind, Baystate Wind, Equinor Wind and Mayflower Wind. The most recent auction in late 2018 led to record high lease prices of \$135 million each. Deepwater Wind also operates a small offshore wind project consisting of five turbines in Rhode Island state waters off of Block Island.



In 2016, Massachusetts passed an energy bill which includes a mandate for Massachusetts utility companies to buy electricity generated by offshore wind located more than 10 miles from shore. In 2017, the state chose Vineyard Wind's proposal to build an 800 megawatt project. Vineyard Wind is currently undergoing state and federal review.

# Nantucket Sound National Historic Landmark (NHL) Act

### **Background**


Nantucket Sound has long been under consideration for protected status and is already eligible for listing on the National Register of Historic Places as a Traditional Cultural Property (TCP). The state waters are protected under Massachusetts law but the federal waters remain unprotected and vulnerable to development.

### Federal legislation

- Designate the Sound as a NHL
- Prohibit energy development
- Protect fishing and traditional uses

### Other protected areas

Similar designations have already occurred in the Cape Cod area with the creation of the Cape Cod National Seashore in 1961 and Congressional designation of Stellwagen Bank as a National Marine Sanctuary in 1992.

I am writing to express my administration's support for the filing of legislation to secure permanent protection for Nantucket Sound by designating it as a National Historic Landmark, recognizing and preserving the extensive and valuable history of the Sound while simultaneously protecting the environmental and cultural resources important to the regional economy.

In 2010, the National Park Service determined that Nantucket Sound was eligible for listing on the National Register of Historic Places. In making this determination, the National Park Service recognized that Nantucket Sound's environmental and historic resources support commercial fishing, marine trades and transportation, tourism, recreation and aviation among other businesses and industries vital to the Cape and Islands. Filing and enacting legislation to provide permanent designation to the Sound ensures that the important history of this area is preserved while continuing to invest in its future. I respectfully request that you consider legislative action to protect this unique and deserving marine environment. Thank you for your consideration of this matter.

#### RE: Nantucket Sound Protection

Dear Senator Markey, Senator Warren and Congressman Keating:

As representatives of Cape Cod, we support federal legislation to secure permanent protection for Nantucket Sound. The Sound is vital to our local economy attracting millions of visitors to Cape Cod, Martha's Vineyard and Nantucket each year. In addition to tourism, the Sound supports commercial fishing, aviation, marine transportation and other marine trades.

Permanent protection would recognize Nantucket Sound's economic value and rich history, environmental quality, further promote tourism and benefit the regional economy. We fully support protection for the historic, environmental and economic resources of Nantucket Sound while allowing for recreational and commercial fishing activities, as well as, other environmentally and economically sustainable uses of the marine environment.

We urge you to enact legislation to designate Nantucket Sound as a National Historic Landmark. Nantucket Sound should be defined as the water body located below the mean low-water line that lies between the southern shore of Cape Cod, between Monomoy and Mashpee, and the islands of Martha's Vineyard and Nantucket.

The legislation should prohibit development of an offshore wind electric generating facility located in whole or in part within Nantucket Sound or any transmission facility connected thereto; however, it should not limit development of electric transmission facilities that exclusively serve or support upland areas or offshore wind electric generating facilities not

located within Nantucket Sound. This legislation should require no additional regulation or management of fishing activities.

Thank you for your interest and prompt attention to this important preservation effort.

- •Work with federal lobbyists to build needed bipartisan support
- Participate in Congressional hearings
- •Launch media campaign after bill introduction
- •Continue development to fund necessary staff, legal and lobbying expenses
